## Official Rules for the Powered-by-Intel LLM Leaderboard Contest

These rules [for online contests include: (including the <a href="www.intel.com">www.intel.com</a> Privacy Notice and Terms of Use)] (the Rules) govern the Intel Powered-by-Intel LLM Leaderboard contest (the "contest") and set out the terms and conditions between Intel Corporation and its affiliates ("Intel" or "us/we") and each participant ("participant" or "you"). A submission to this contest constitutes your acceptance of these Rules.

- 1. How to Enter: Intel Corporation, (the "Sponsor") is offering Powered-by-Intel LLM Leaderboard contest (the "Contest") and will award prizes based on the results of judging all valid entries against the criteria established in these Official Contest Rules (the "Rules"). Submit a valid LLM for evaluation through the Powered-by-Intel LLM Leaderboard evaluation submission form between May 31<sup>th</sup>, 2024 11:59PM and January 31<sup>th</sup>, 2025 11:59PM ("contest period"). During the contest period submit your entry by visiting <a href="https://huggingface.co/spaces/Intel/powered by intel Ilm leaderboard">https://huggingface.co/spaces/Intel/powered by intel Ilm leaderboard</a> and completing the submission form found under the "submit" tab.
- 2. Eligibility: Contest is open only to residents of the United States of America, United Kingdom, Germany and EU countries, India, and Canada (excluding Quebec). Residents of the countries not listed above are ineligible. All national and local laws and regulations of the contestant's country of residence apply. Residents of countries under the latest U.S. embargo are not eligible to enter. Contestants must be 18 years of age or older. Employees, officers and representatives (and members of their immediate families and those living in the same household of each) of Intel Corporation, its parents, subsidiaries and affiliated companies, advertising and promotion agencies and any company involved in the design, execution, production or judging of this promotion ("contest entities") are ineligible. Void where prohibited.
- 3. **Entry Requirements**: All entries must be submitted through the leaderboard's evaluation submission form, which can be found at <a href="https://huggingface.co/spaces/Intel/powered\_by\_intel\_Ilm\_leaderboard">https://huggingface.co/spaces/Intel/powered\_by\_intel\_Ilm\_leaderboard</a> under the "submit" tab. All submissions must abide by the following requirements:
  - a. The evaluation submission form must include the following fields: Model Name, Revision Commit, Model Type, Training Hardware, Precision, Weights Type, Training Infrastructure, Affiliation with Intel, Base Model, and a valid Email Address.
  - b. Models must be published to the Hugging Face Model Hub under one of the following opensource licenses: Apache-2.0, MIT, Llama2, CC-BY-NC-ND-4.0, CC-BY-NC-4.0, or CC-BY-NC-SA-4.0. Each model card must mention the hardware, software, and infrastructure used for training.
  - c. To be eligible for prizes, the submitter must be an individual directly involved in the pretraining, fine-tuning, or chat-tuning of the model. Models submitted must have been pretrained, fine-tuned, or chat-tuned on one or more of the following platforms: Intel® Gaudi® Accelerators, Intel® Scalable Xeon Processors, Intel® Max Series GPU, Intel® Arc™ Professional A-Series Graphics, or Intel® Core Ultra Processors.
  - d. Your model must pass the evaluation workflow and achieve a valid rank on the leaderboard. Models resubmitted for evaluation are only eligible for prizing if there is a net improvement of at least 1 point in their average score on the leaderboard.
  - e. Participants must agree to all terms and conditions of the competition and must be willing to keep the model on the Hugging Face Model Hub for a period of 180 days.
  - f. Make sure all required fields are completed accurately. Check the open-source license compatibility before submitting your model. Ensure that your model card provides detailed information about the training environment. Confirm that your model meets the platform requirements. Review the leaderboard evaluation process to understand how your model will be ranked. Consider the impact of any resubmission on your model's leaderboard score.

- 4. **Judging**: Submissions will be judged on an ongoing basis by Intel engineers, Eduardo Alvarez, Benjamin Consolvo, and Ugonna Chikezie, subject to change. Judges will evaluate all eligible submissions on the following criteria: [average of the cumulative score of the following benchmarks from the Eleuther Al Harness: ARC, HellaSwag, MMLU, TruthfulQA, Winogrande, and GSM8K.]. All decisions are within the sole discretion of judges and are final. You may withdraw your submission at any time by notifying Sponsor. If a submission is withdrawn, your right to win a prize is terminated.
- 5. **Ownership and Publicity**: Sponsor does not claim ownership of your submission to the contest; but by submitting an entry, you are granting Sponsor and its affiliated companies the following worldwide, non-exclusive, perpetual, irrevocable, royalty-free, unconditional, fully paid-up rights: (1) to make, have made, use, copy, reproduce, modify, and create derivative works of the contributions, (2) to publicly perform or display, import, broadcast, transmit, distribute (directly and indirectly through multiple tiers), license, offer to sell and sell, rent, lease, or lend copies of the contributions (and derivative works thereof), (3) to sublicense to third parties the foregoing rights, including the right to sublicense to further third parties, and (4) to publish your name or alias in connection with this contest and your contributions.

Contestants understand and agree that their submission may be posted and publicly viewable. By providing a submission, you grant Sponsor and its affiliated companies the right, except where prohibited by law, to use your name for promotional purposes in promoting or publicizing the contest. Sponsor, however, does not have any obligation to use the winning Entries for any purpose.

- 6. **Participant Warrants**: By submitting an entry, you warrant that your submission:
  - does not contain any content that infringes on any third-party intellectual Property (IP) rights, and that you own or otherwise have all rights necessary for the submission including all IP rights.
  - does not disclose any information which would constitute a violation of a confidentiality obligation.
  - does not contain any viruses, worms, spy ware, or other components or instructions that are malicious, deceptive, or designed to limit or harm the functionality of a computer; and
  - is not subject to license terms that require any software or documentation incorporating or being derived from your contributions to be licensed to others.
- 7. Prizes: A single prize awarded monthly for the top model. Prizes will consist of US \$500 dollars [or US dollar equivalent] in cash. Limit of one prize per submission. Winners will be notified via email within fifteen [15] days from judging. If after seven [7] days of the second notification to the winner no acknowledgement or response is received, the prize is forfeited, and Sponsor will select another winner.

Prizes will be distributed by BeMyApp to eligible winner(s). Prizes will be processed within approximately 120 days of the official winner's announcement. The winner is required to provide their full legal name, email address, mailing address, phone number, and relevant information to BeMyApp within 14 days of the initial notification. The winner may also be required to complete an income tax form, such as a W-9 or W-8BEN, or provide other relevant documents as requested. The winner may be disqualified and lose the profit of the prize if (1) any of the required information or documentation provided by the winner is unusable (illegible, incomplete, or erroneous); (2) the winner does not provide all the required information requested; (3) the winner is ineligible to receive the prize under United States or local law; (4) the winner does not respond within 14 days of two attempted prize notifications; or (5) the winner is a resident of a country

that is not eligible to participate or receive a prize payment.
