**ONLINE SWEEPSTAKES RULES**

**1. Eligibility**

The oneAPI CUDA to SYCL Migration Hackathon is open only to legal residents of legal residents of the 50 U.S. states, the District of Columbia, the United Kingdom, France, Netherlands, Switzerland, Germany, Japan, Canada (excluding Quebec), South Korea, and Taiwan who have reached the age of majority in their state of residence at the time of entry. Employees of Sponsor and its parent companies, affiliates, subsidiaries, distributors, advertising and promotion agencies and members of the immediate family (defined as spouse, parent, sibling, child and respective spouses regardless of where they reside) and/or those living in the same household of such employees are NOT ELIGIBLE to enter.
